

## PIONEER HIGH SCHOOL DANCE CONTRACT

*In order to promote a healthy, safe, enjoyable evening for all students, the following procedures will be in place for PHS dances. All parents and students must read, understand, and sign this agreement. Pioneer High School encourages families to discuss these rules together with their students and to copy this document for future reference.*

This is a dance contract for students who are currently attending Pioneer High School. This contract must be fully understood by students and guardians and must be filled out completely. Students must submit this contract in order to be eligible to attend school sponsored dances. This contract will only need to be submitted once per school year.

I, \_\_\_\_\_ agree to the following PHS dance guidelines:

- ❖ I will demonstrate good character, maintain a high community standard, and follow all school rules.
- ❖ I will follow the school dress code.
- ❖ I understand that once I enter the dance, I am not permitted to leave and enter again.
- ❖ I will remain tobacco, drug, and alcohol free at all times.
- ❖ I understand that, prior to being admitted to the dance, my person and or possessions may be subject to search for illegal or controlled substances. This includes any purse or bag that I bring into the dance. I may also be subject to a breath test and/or searched if showing signs/symptoms of intoxication.
- ❖ In order to enter the dance, I must have my PHS student ID.
- ❖ I will not be admitted to the dance one hour past the official start time (unless I have an acceptable excuse such as an athletic event/practice or medical issues)
- ❖ I will follow all rules pertaining to dancing, such as, but not limited to, the following:
  - ❖ No pushing or “moshing”
  - ❖ No straddling legs or bending over
  - ❖ No overt public displays of affection
  - ❖ Both feet must remain on the floor
  - ❖ Hands must remain on waist or shoulders only

Any student who fails to abide by the dancing rules will receive a warning, which will be recorded. If that student is caught dancing inappropriately a second time, a final warning will be issued and recorded. If a third offence occurs, the student will be escorted out of the dance.

By signing this contract, I am agreeing to follow all dance rules, and I understand that failure to follow these rules may result in removal from the dance and loss of dance privileges.
